

## **2026 Future Banker Scholarship Application**

The Texas Bankers Foundation has established the Future Banker Scholarship to promote excellence in the field of banking. The Foundation offers scholarships to deserving undergraduate and graduate students in the Banking program at each university — Sam Houston State University, Texas A&M University and Texas Tech University — who has completed a banking or regulatory internship. \$2,500 in scholarship funds is available for each university program. Amount of each scholarship awarded will be determined by members of the Texas Bankers Foundation Scholarship Committee. Minimum scholarships start at \$1,000.

#### Selection will be based upon:

- GPA Minimum of 2.8
- Major Banking, Finance and/or Certification in Commercial Banking
- Completion of Banking or Regulatory internship
- Statement of career goals
- Letter of recommendation

#### Applications must include:

- Completed application form
- Statement from applicant, including
  - What you learned during your internship
  - Career goals
  - Why you want to be a banker
- Letter of recommendation (from internship supervisor preferred)
- Unofficial transcript
