



# **2025 50-YEAR BANKER AWARD**

The Texas Bankers Association is proud to promote for the 36<sup>th</sup> consecutive year the recognition of bankers who have devoted 50 years or more of service to the banking industry. All eligible nominees will be honored at a luncheon at TBA's Annual Convention in April 2025.

# **Eligibility:**

Any Texas banker who has attained at least 50 years or more of credited service prior to December 31, 2025, is eligible. Eligibility is also subject to the following conditions:

- At least 10 years of banking in Texas is required; and at the time of proposal for the award, such person shall be active as a director, officer or employee of a Texas bank, bank holding company or bank holding company subsidiary whose principal purpose is to supply bank-related services.
- If the candidate completed 50 years of service to the industry and subsequently retired from a Texas institution, the award may be bestowed in retirement.
- Years of banking service rendered in other states may be credited if the above condition is met.
- U.S. military service counts in the 50-year span if the nominee is in banking prior to and subsequent to the time spent in military service.
- Years after retirement in which the candidate works part-time for a bank, as a consultant for a bank, or as a member of the Board of Directors may be counted toward the 50-year total; however, these endeavors must be the principal endeavors of the candidate for those years to be counted.
- Bank membership in the Texas Bankers Association must be current.
- The 50-Year Banker Award may be presented posthumously if the candidate had qualified for the award prior to death.

## 50-Year Banker Award recipients will:

Honorees will receive an award commemorating the milestone and a booklet that includes a picture and brief biographical sketch of each award recipient. Honorees will be recognized in Texas Banking magazine and in posts on TBA's social media channels. A press release honoring all of the 2025 honorees will be distributed by TBA.

#### Nomination should include:

- The completed nomination form signed by the bank president, CEO or board chairman.
- Nominee's completed answers to each of the questions asked on the nomination form. **Questions and answers may be submitted in a Word Document if more convenient**.
- Glossy headshot of nominee.
- Additional photos of the nominee for the presentation video. Include 7-10 high resolution photos of honoree at bank and community service events (past as well as more recent). Please also provide 3-4 family photos.

## Entries must be submitted by Tuesday, December 31, 2024.

Please keep a copy of the entry, and do not submit irreplaceable materials.
