2020 Future Banker Scholarship Application

The Texas Bankers Foundation has established the Future Banker Scholarship to promote excellence in the field of banking. A \$2,500 scholarship will be awarded to a deserving undergraduate student in the Banking program at each university — Sam Houston State University and Texas A&M University — who has completed a banking or regulatory internship.

Selection will be based upon:

- GPA – Minimum of 2.8
- Major – Banking, Finance and/or Certification in Commercial Banking
- Completion of Banking or Regulatory internship
- Statement of career goals
- Letters of recommendation

Applications must include:

- Completed application form
- Statement from applicant, including
 - What you learned during your internship
 - Career goals
 - Why you want to be a banker
- Two letters of recommendation (one from internship supervisor)
- Unofficial transcript
